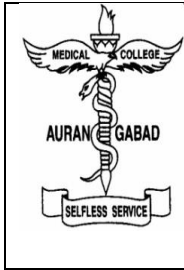

RULES & REGULATIONS

(Before filling ONLINE application form, read rules and regulations carefully):

1. A candidate must be citizen of India. Candidate should have Nationality certificate of India.
2. Eligible Candidate must have born on or before 31-12-2007.
3. Candidate should have passed 10th & 12th Std. (12th science) examination from the institute situated in state of Maharashtra only.
4. Domiciled Candidates of Maharashtra are **only** eligible. The candidate shall submit Domicile Certificate (**अधिवास प्रमाणपत्र**). Residential Proof (**रहिवासी/रहिवास**) will not be accepted.
5. **A candidate Domiciled in Maharashtra but having constitutional reserved category documents of other states will not be eligible for a reserve category claim.**
6. Candidates who have passed 12th (HSC) examination with Physics, Chemistry & Biology (PCB) or other vocational course subjects (as per clause.7) with minimum 50% marks for Open Category students (PWD open 45%) and Reserved Category students minimum 40% marks.

7. Candidate who has passed 12th Std. examination with the Vocational subjects
 - a) Medical Lab Technician-1, Medical Lab Technician-2, Medical Lab Technician-3 shall be eligible for B.sc in Paramedical Technology (Laboratory) course **only**.
 - b) X-ray Lab Technician-1, X-ray Lab Technician-2, X-ray Lab Technician-3 shall be eligible for B.sc in Paramedical Technology (Radiography) Course **only**.
 - c) Like this for other Subjects.....i.e., Optometry etc.
8. Application will NOT be accepted via email/Fax/Post/Courier if forwarded to the institute.
9. All documents enlisted in the Holding Certificate will be compulsorily required to be uploaded during online application form submission. Kindly note, instead of Mandatory documents if wrong documents / Receipts / acknowledgments / undertaking is uploaded by the applicant then the online application is liable for rejection. No grievances in this regard will be considered by the institute.
10. All necessary original documents will be required at the time of admission. Receipts/ acknowledgements /undertaking on bond will **NOT** be considered as an alternative to any documents. **It is important to note that NO certificate(s) will be added during admission after the last date of submission of the ONLINE Application.**
11. Based on the Documents uploaded category of the student will be fixed, and Provisional Merit List will be prepared & displayed on the website. Kindly note, a student cannot add or produce any new documents for consideration during the admission process.
12. Final admission in an assigned category will be based on submission of all required ORIGINAL DOCUMENTS at the time of admission. The confirmation of admission and rejection of admission will be the final authority of the institute's head based on Documents produced during admissions.
13. Provisional Merit & Selection list will be displayed on the Govt. Medical College, Chhatrapati Sambhajinagar college website (www.gmcaurangabad.com).
14. The source of all information pertinent to the advertisement, amendments to the advertisement, selection and joining will be made available on the college website: www.gmcaurangabad.com. Students should regularly check the website for updates/changes/amendments. **No information will be given at the institute level.**
15. Provisional Merit shall be based on the total marks obtained in HSC-PCB (Physics, Chemistry & Biology). In the case of the vocational subject as per total marks obtained in a particular subject will be the merit criteria.
16. For preparing the merit list, total marks of PCB after considering attempts shall be considered (for calculating the final total marks of PCB marks, a subject-wise attempt shall be made applicable; for each subject, if the candidate has attempt, 2 marks will be deducted per attempt per subject).
17. If tie of PCB total persists then, the grand total of HSC marks, followed by grand total marks of SSC, followed by age will be the criteria for preparing the merit list.

18. Category students should produce a Caste certificate, Caste validity & Non-Creamy layer certificate valid up to 31-3-2025. It is important to note that all category documents will be required for category claims, Receipts/acknowledgements of proposals submitted to the social welfare department or Tribal department /undertaking on bond, will **NOT** be accepted as an alternative to category documents. In the absence of Caste certificate, Caste validity & non-Creamy layer certificate the candidate will be considered as Open for the selection process if he/fulfils the criteria stated in clause no.6
19. As per Govt. of Maharashtra G.R. No. Misc.2024/C.R.75/Reservation-5 dated 22nd July 2024 and G.R. No. Misc.2024/C.R.75/Reservation-5 dated 5rd Sep.2024 candidate belonging to SEBC and OBC category can produce his/her Caste Validity Certificate upto six months from the date of application for admission to the Health Science courses, failing which his/her admission will stand cancelled and he/she will be responsible for the same.
20. Candidates claiming EWS should submit the EWS certificate (**Annexure-A**) in the prescribed format issued by Govt. of Maharashtra issued on or after 31st March, 2024.
21. One percent of seats from Open category are reserved in parallel for Orphan category candidate. “**Orphan**” means a child— (i) who is without biological or adoptive parents or legal guardian; or (ii) whose legal guardian is not willing to take, or capable of taking care of the child; as defined in the Juvenile Justice (Care and Protection of Children) act 2015 and Government Letter no. MED-1018/C.R.201/18/Edu-2, Dated 20th June, 2018. **Such a candidates will be required to submit Orphan Certificate from Women & Child Welfare Department. No other certificate issued by any other authorities will be considered for orphan claim.**
22. Inter-se amongst the reserved categories will be operated at the end of each admission process against the unfilled reserved categories seats as per merit and choice of the reserved category candidates. The seats remaining vacant from various categories will be filled in during inter-se admission process as follows:
- From among the candidates of their respective group from the Inter-se Merit List of that particular group where the vacancies exist.
 - If the seats still remain vacant, then the seats will be filled, from among the candidates of all the categories mentioned above from all categories combined merit list.
 - If the seats remain vacant then the seats will be filled from among the candidates of the common merit list.
 - The seats remaining vacant from EWS category will be allotted to general category candidates.

The groups are as follows:

GROUP-I

- (i) Scheduled Castes and Schedule Caste converted to Buddhism (S.C.) 13%
- (ii) Scheduled Tribes including those living out-side specified area (S.T.) 7%

GROUP-II

- (i) Vimukta Jati (DT) (A) 3%
- (ii) Nomadic Tribes (NT1(B)) 2.5%

GROUP-III

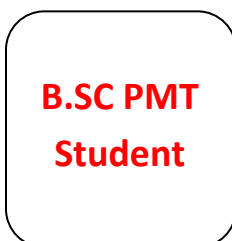
- (i) Nomadic Tribes (NT2 (C)) 3.5%
- (ii) Nomadic Tribes (NT3 (D)) 2%
- (iii) Other Backward Classes (OBC) including SBC 19%
- (iv) SEBC 10%
- (v) EWS 10%

23. Students can fill minimum One (1) to Maximum 11 choices. While filling the choices it is highly advisable to all students to fill all choices available. Choices once filled at the time of Online application filling process will be full and Final. Don't just fill choices which are allotted for your category but fill all the choices available. As per the preferences/choices seat will be allotted. In subsequent rounds (If any) higher choices will be considered for allotment. Shifting to higher choices is dependent on "Status Retention submission". If status retention is not given, the student will be compulsorily shifted to higher choices if seats are available in subsequent rounds (If any).
24. Candidates will be required to submit all original certificates at the time of joining. **Admission will not be finalized without the submission of all required original documents. No time will be allowed to submit Documents later, also no undertakings/ receipts of submission will be accepted for any documents if not available. Such candidates will be rejected during admission process and these candidates will not be eligible for Subsequent rounds.**
25. **FEES:** Demand draft of total fees from the nationalized bank as prescribed in the advertisement will be required for joining an allotted seat. **Cash/Cheque will not be accepted.**
26. **STATUS RETENTION:** It means the student can freeze the allotted choice after allotment.
27. Giving status retention is not compulsory. Students who have submitted status retention will not be considered for allotment of higher choices in subsequent rounds. The students can give Status Retention in the prescribed format on or before **22-11-2024** till 5:00 PM to the institute. **Once status retention is given the seat allotment of the candidate becomes full and final.** All allotted seats will automatically become full and final after the cut-off date. Even if the seat remains vacant because of Not joining, No Upgradation in higher preferences will be permitted after the Cut-off date.
28. In subsequent rounds, there will be a compulsory shifting for higher choices for all those candidates who have not submitted the Status retention.
29. **The cut-off date of admission is 29-11-2024. If for any reason, an admission cancellation request is submitted by the student after the Cut-Off date, then FEES WILL NOT BE REFUNDED.**
30. **CONDUCT AND DISCIPLINE:** Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process. It is the responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits, and expulsion of the candidate from the college by the Dean or by an authorized official.

If any candidate / authorized representative or person accompanying is found obstructing the admission process or trying to influence in an unlawful manner/ creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken. The decision taken by the Dean/authorized person in this respect shall be final and binding.

31. In case the seats remain Vacant after cutoff date and Govt./University issues notification for extension rounds, then the following rules will be followed:
- Only waiting list candidates will be eligible for the extended round. No fresh applications will be called.
 - The students who were allotted seats in the rounds before cut-off date and have **not joined**, will **NOT** be eligible for vacant seats.
 - All students who have joined in the rounds before cut-off date will also be **NOT ELIGIBLE** for extended round/vacant seats. No up-gradation will be permitted to students who have already joined before cutoff date. Any representation in this regard will not be considered for reply.
 - If seats remain vacant after allotting to waiting students in extended rounds. Fresh application will be called, and the remaining seats will be allotted.
32. Only one Parent & Student will be allowed inside the CET CELL during admission process. Students and parents should strictly follow social distancing, should compulsorily wear mask, and use personal sanitizer's during the admission process.
- 33. Kindly note, No Hostel Facilities is available for B.Sc PMT students.**
34. All selected students should use white apron and the pocket of apron shall have compulsory print or embroidery as below: The dress code if Decided by the institute shall be mandatory for all B.Sc PMT students. Strict action will be initiated against students not following the instructions.

36. The Dean, Government Medical College, Chhatrapati Sambhajnagar will be the final authority for interpretation of any rules/conditions stated in this advertisement, changes in the seat matrix for appropriate reasons. The decision of Dean will be final and binding on the candidates.
37. Regular Teaching classes will start from 2nd December 2024.

Admission Process: -

1. Those candidates who are selected shall report personally along with all original documents and photographs along with the Demand Draft of applicable fees as mentioned in the Holding Certificate. (No other person on behalf of the student will be allowed for participating in the admission process **“PROXY NOT ALLOWED”**)
2. Kindly note, as per the provisional Merit list and category allotted to the students based on the online application form and documents uploaded, Final admission confirmation in a particular category will be based on the submission of all required ORIGINAL DOCUMENTS at the time of admission. The confirmation of admission and rejection of admission will be the final authority of the institute's head based on Documents produced during admissions.
3. Those students who have not taken admission in the selected round list **will not be eligible** for the subsequent round.
4. Those candidates who do not produce all the required original documents at the time of admission he/she will not be eligible for admission. No representation in this regard will be answered by the institute.
5. Please note if in case the mop-up round for vacant seats is conducted, it will be online, but the admission process shall be confirmed offline, by the physical presence of the students only. Those candidates who want to take admission in Mop-up round must submit all required original documents, and photographs along with the Demand Draft of fees as mentioned in the holding certificate.
6. The candidate who took admission and subsequently not joined in the respective department before cutoff date i.e.29/11/2024 or cancel admission after cutoff date, such candidate admission fees will not be refunded.
7. The cut-off Date for the admission process is 29/11/2024 up to 05.00 PM.

Please note that if a candidate commits any mistake in filling out the online Application Form, it cannot be corrected by this office. The Office will take no responsibility of any kind for such forms.

The Applicant must possess the required criteria and educational qualifications as mentioned in the Information brochure.

Applicant's **Email ID and Mobile** number will be used for further correspondence.

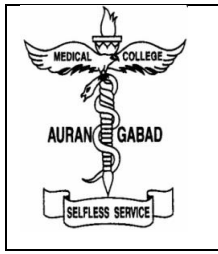

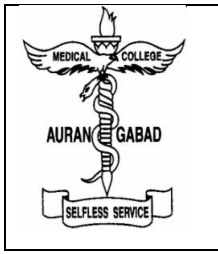
