

**Note:**

1. As per the seats allotment in Round-2 the candidate should report for Joining between 24-12-2024 to 30-12-2024. The last Day for Joining is 30-12-2024 upto 5 PM only. Candidate Should report for Admission in Person (Proxy will not be allowed on behalf of Student)
2. Joining will be compulsory for consideration in subsequent rounds..
3. Kindly note, a student who is allotted a seat & does not join, he/she will be out of admission process.
4. The Institute shall confirm joining only after submission of ALL ORIGINAL DOCUMENTS as mentioned in the Information Brochure. It is hereby made clear that submission of all original document is must, Otherwise the claim will be REJECTED. A candidate will not be permitted for provisional admission on any grounds or any alternatives, in absence of REQUIRED ORIGINAL DOCUMENTS. No additional time for submission of required original documents will be permitted.
5. At the time of admission, It will be compulsory to submit Fees as Demand Draft only (cash/Cheque will not be accepted). Without fees DD admission will be REJECTED.
